
# Quarterly Report AACI in Action

### AACI Call Series

After the COVID-19 pandemic required social distancing restrictions for the majority of the country, AACI began to explore ways to keep its membership engaged with Washington. As a result, AACI launched its weekly call series, giving its members an opportunity to engage with Members of Congress, administration officials, university professors, and other senior Capitol Hill staff on a weekly basis.

During the calls, Members of Congress and their staff updated participants on congressional activity related COVID-19, such as changes to SBA's Paycheck Protection Program (PPP), complications in the food supply chain and meat processing sector, and details of USDA's Coronavirus Food Assistance Program (CFAP).

On the Administrative side, AACI connected with RMA Administrator Martin Barbre and his staff, who

USDA Chief Economist Dr. Robert Johansson provided members with an in-depth presentation on the current economic situation and the forecasts for U.S. crops, livestock, and trade.

Outside of the beltway, Dr. Bart Fisher, Co-Director of the Agricultural & Food Policy Center at Texas A&M University, provided an overview of s relief programs available for agriculture and an in-depth analysis of payment distribution under USDA's CFAP.

In holding these weekly calls, AACI staff hopes to continue to provide valuable insight to the policy landscape in Washington, D.C., and, at the same time, keep its members well-aware of what's happening across the country in the agriculture community.


### COVID-19 & Agriculture

On May 12, House Democrats laid out their opening bid for new stimulus funding when they unveiled their \$3 trillion coronavirus relief bill, the Health and Economic Recovery Omnibus Emergency Solutions (HEROES) Act. The bill included several agriculture-related provisions, such as: an additional \$16.5 billion for direct payments to agricultural producers to cover losses resulting from COVID-19; aid for biofuels plants and dairy producers; and compensation for livestock and poultry producers who have had to euthanize animals that couldn't be processed. The bill passed narrowly in the House by a vote of 208-199, but is all but dead in the Senate, where GOP Leaders are waiting to see how the first rounds of aid play out. However, Senators are currently negotiating a package of their own with an expected price tag closer to \$1 trillion.

On June 5, President Trump signed into law the Paycheck Protection Program Flexibility Act, solidifying changes that will grant businesses greater flexibility in using the Small Business Administration's Paycheck Protection Program (PPP). Specifically, the law reduces payroll requirement for forgiveness from 75% to 60%, extends the loan forgiveness period from 8 weeks to 24 weeks, increases the minimum maturity for a PPP loan to five years, and changes coverage period for PPP to Dec. 31, 2020, among other things.

After the announcement of USDA's Coronavirus Food Assistance Program (CFAP) in mid-April, the department issued a press release on May 19 providing details about the program, and notified stakeholders that sign-up for CFAP would begin on May 26. By June 7, USDA had distributed \$1.4 billion in payments, with \$676 million going to livestock producers, \$337 million to dairy farms, \$368 to row crops, and less than \$25 million to specialty crops.

As COVID-19 caused a sharp decline in meat processing due to worker infections, temporary closures, and the implementation of distancing and other measures, President Trump's issued an Executive Order on April 28 directing meatpacking facilities to implement the CDC and OSHA guidelines created for the meat and poultry sector. By June 9, Secretary Perdue announced that across the cattle, swine, and broiler sectors, processing facilities are operating more than 95% of their average capacity compared to this time last year.

I am a proud member of the bipartisan Congressional Crop Insurance Caucus. I know how important crop insurance is for Kansas and the third district, which is home to CGB Diversified and ProAg.

This year has been especially tough for many farmers in Kansas with drought conditions and the Coronavirus impacting the food supply chain. I am glad that Congress was able to secure assistance for farmers, including the Coronavirus Food Assistance Program (CFAP). I recognize the ongoing challenges this pandemic presents to both farmers and crop insurers.

I also requested that the Appropriations Committee support strong funding for rural infrastructure programs in Fiscal Year 2021 that will provide stability to the agriculture industry in Kansas and beyond – including for the Rural Utilities Service (RUS) Electric Loans, the Rural Decentralized Water System, and the Circuit Rider Program.

I will continue to work with my colleagues on both sides of the aisle and with AACI members in support of our agricultural industry and to ensure we are protecting vital risk management tools for our farmers and ranchers.

### Meet the Inaugural Leadership Class

Beginning in 2021, the American Association of Crop Insurers (AACI) is launching its leadership development program, Seeding the Future, to identify and train a new generation of leaders within the crop insurance industry. The program will focus on giving these individuals the tools and resources needed to be effective representatives of AACI and the crop insurance industry both in Washington, D.C. and throughout the country, including assisting in the development of important relationships and building out a network of policy influencers. The individuals selected for the program will participate in four separate courses over the span of two years, followed by two other activities the following year. A brief summary of the four courses are as follows:

History & Mission: To understand the history and evolution of the federal crop insurance program and AACI

Communication & Leadership: To understand the political messaging around how to communicate effectively with members of the press and policy makers.

PAC, Grassroots & Policy: To understand how PACs work and how to organize events, to gain an understanding of how district offices function; NCIS's role as it relates to AACI, and the industry as a whole.

**Political & Policy:** To understand policy development and implementation through legislative and executive branch decisionmakers, as well as other leaders of agriculture and conservation organizations.

After successful completion of the four courses, leadership class participants will be required to complete two or three additional activities with the help of AACI staff before being recognized at the AACI-NCIS annual meeting. AACI hopes the creation of the leadership program, Seeding the Future, will help encourage AACI members to become more involved with the association and help prepare individuals for potential leadership positions within the association
